Nominee Criteria

Nominations are open to both individuals or businesses. In either case, the candidate must exhibit and embody the mission of YWCA: ***eliminating racism, empowering women, and promoting peace, justice, freedom and dignity for all.*** YWCA advocates for justice worldwide for women and their families. Candidates should be leaders who champion civil rights, diversity, social justice, and programs to empower women and people of color.

Locally, YWCA Metropolitan Phoenix is particularly focused on the issues of immigration and Census 2020, women’s access to healthcare, and recidivism and reentry for female prisoners. Special consideration will be given to nominees who have made contributions to these focus areas.
